Better with Help from Indian River **Community Foundation** HELP FROM

In Fiscal Year 2020-2021, the Community Foundation awarded a record 1,547 grants for a total of \$11.4 million through donor advised and other types of funds. Almost \$1 million was awarded in discretionary grants to meet some of our community's most pressing needs and to preserve some of our community's most treasured resources. Here are three examples that made a significant impact.

Youth Guidance Mentoring Academy — \$30,000

Last year, 40 percent of Indian River County's third-grade students are not able to read, and 35 percent of eighth-grade students are not proficient in math. Led by executive director Phil Barnes, Youth Guidance Mentoring Academy is dedicated to enriching the lives of Indian River County youth through mentoring relationships that inspire trust, self-esteem and positive futures. Through one-on-one and group mentoring programs, Youth Guidance helps kids build a path out of poverty toward greater prosperity. This grant provided operating support to help the organization respond to students impacted by COVID-19 by opening an all-day learning center to prevent further learning loss and to help maintain academic progress.

Hope for Families Center — \$50,000

Last year, more than 500 students enrolled in School District of Indian River County schools were homeless. While many of these children lived in shared housing, others lived in shelters, motels, cars and outdoors. For the last several years, Dr. William Cooney has served as chairman of the Hope for Families Center board of directors, leading efforts to transition families from homelessness to sustainable permanent housing. This grant provided operating support for proven, dignified programs that meet the needs of homeless children and their families.

Indian River Land Trust — \$100,000

Indian River Land Trust protects the land that protects the Indian River Lagoon. In doing so, the organization preserves and protects more than 1,200 acres and 12 miles of shoreline, while providing public recreation and education to visitors and residents of the community. This meaningful work will be bolstered by the success of a recent \$12 million "Campaign to Protect the Land that Protects the Lagoon," led by honorary co-chairs Bill Buck, Dick Brickman, and Ned Dayton. This grant provided support to help complete the campaign.




